

Terms and Conditions

Valid since 1 May 2018.

By ordering and using the Services, the Client and the Provider asks and confirms their commitment to comply with the Terms and Conditions set forth below as well as these Terms and Conditions are printed and signed in the form of a contract. The Terms of Service govern the contractual relationship between the Provider, which is:

(hereinafter referred to as the provider)

and

the client. The client is a natural or legal person who has ordered a service or is listed as the owner and payer of the provider's database.

1. Definition of other terms

1.1. Service - oral or written consultation, registration of a self-employed person or legal entity, establishment of a bank account and so on.

1.2. Pricelist - The current pricelist is published at www.domytax.cz.

2. Client's rights and obligations

2.1. The client is obliged to state his / her email when ordering the service.

2.2. The client is required to protect the provided access names and access passwords to established services and server resources from third party misuse.

2.3 The Client is fully responsible for the use of the casatax system and the data stored in it.

2.4 The Client agrees to accept the terms and conditions of use of cookies.

3. The rights and obligations of the provider

3.1. The Provider is obliged to provide the service.

3.2. Breach of the obligation of the Provider to ensure the continuous service of the service is not interruption of the operation of the service resulting from unavoidable objective reasons (eg power outage, outage of the internet point etc.) or interruption of operation due to system interventions of the provider in operation of the server.

3.3. The Provider has the right to suspend the service to a client who is in default with payment for the service for more than 5 business days.

3.4. The Provider has the right to cancel the service for a client who is in delay with payment for the service for more than 30 business days.

3.5. Provider has the right to terminate the service to a client who deliberately damages the application or attempts to bypass tariff restrictions.

3.6. Provider has the right to change these terms and conditions upon prior notice by the client.

4. Fees and charges

4.1. The service allows you to use a free FREE tariff, which is not limited by the length of use.

4.2. Service payments are made in advance and are non-refundable.

4.3. Changing the service tariff is immediate. The invoice for the new tariff will be issued after the end of the period that has been paid by the previous invoice.

5. Protection of personal data

5.1. Article 13 of Regulation (EC) No 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Regulation on the protection of personal data) (hereinafter referred to as the "GDPR Regulation") related to the processing of client's personal data for the purpose of performing the service, for the purpose of negotiations on the service and for the fulfillment of the public obligations of the seller, is fulfilled by the seller through a special document.

6. Sending business messages and storing cookies

6.1. The client agrees to send information related to the services or the seller's business to the client's electronic address and also agrees with the sending of commercial communications by the provider to the client's electronic address. The information obligation towards a client within the meaning of Article 13 of the GDPR Regulation related to the processing of client's personal data for the purpose of sending commercial communications is fulfilled by the provider through a separate document.

6.2. The client agrees to store so-called cookies on his computer. If the ordering of the service on a web site is possible and the obligations of the service provider to perform without the so-called cookies being stored on the client's computer, the client may withdraw the consent under the previous sentence at any time.
